The County of Accomack is accepting proposals from qualified, licensed contractors to clean both interior and exterior, repaint and provide ongoing maintenance services for the 250,000 gallon, 124' high, steel water tank and appurtenances located at 29201 Service Road in Melfa near the County Airport. INVITATION FOR BIDS #639

The County of Accomack, Virginia is soliciting sealed BIDS for replacement of the floor in the waste receiving building located at the Accomack North Landfill. The work is to be completed as shown on the Contract Drawings and as described in the specifications. The work generally consists of:

1. Removal of existing asphalt and stone base.
2. Excavation of soil subbase.
3. Construction of new concrete floor within the building.
4. Installation and placement of new metal plate at waste conveyor.

Sealed BIDS will be received at the County of Accomack, County Administrator's Office, 23296 Courthouse Avenue, Suite 203, Accomac, Virginia 23301, Attn: Darlene C. Burton, Purchasing and Contracts Manager, 757 787-5700, in writing, no later than 2:00 PM according to the official clock in the County Administrator's Office, on June 7, 2012, and then opened at said office and read aloud. A non-mandatory prebid meeting will be held on Thursday, May 24, 2012, 10:00 am at the Accomack County North Landfill. Attendance at the prebid meeting is encouraged. Additional site visits may be arranged through the County Department of Public Works.

BIDS must be submitted in a sealed opaque envelope and clearly marked on the outside with the company's name and the notation "Sealed Bid for Accomack North Landfill – Baler Floor Replacement.
